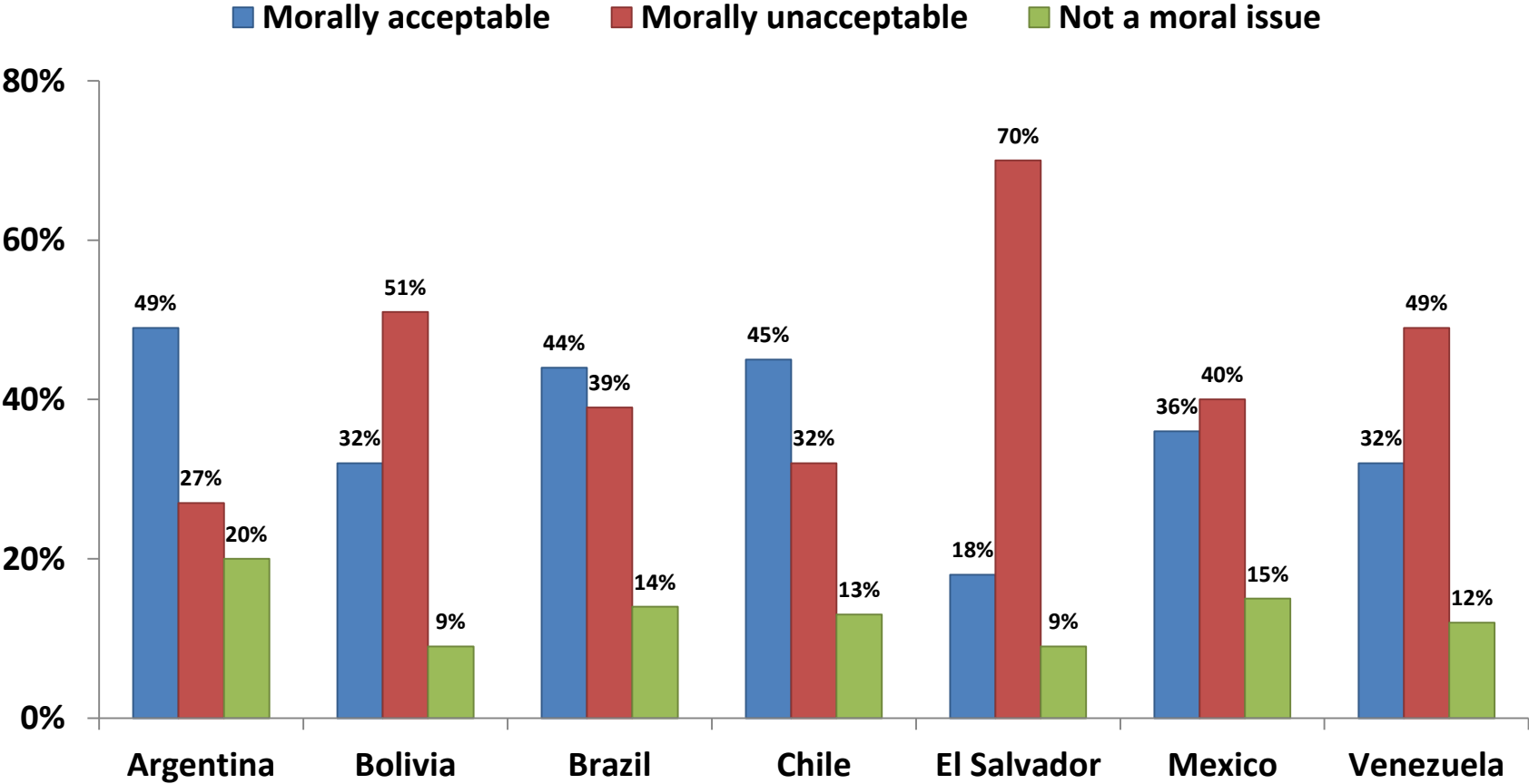

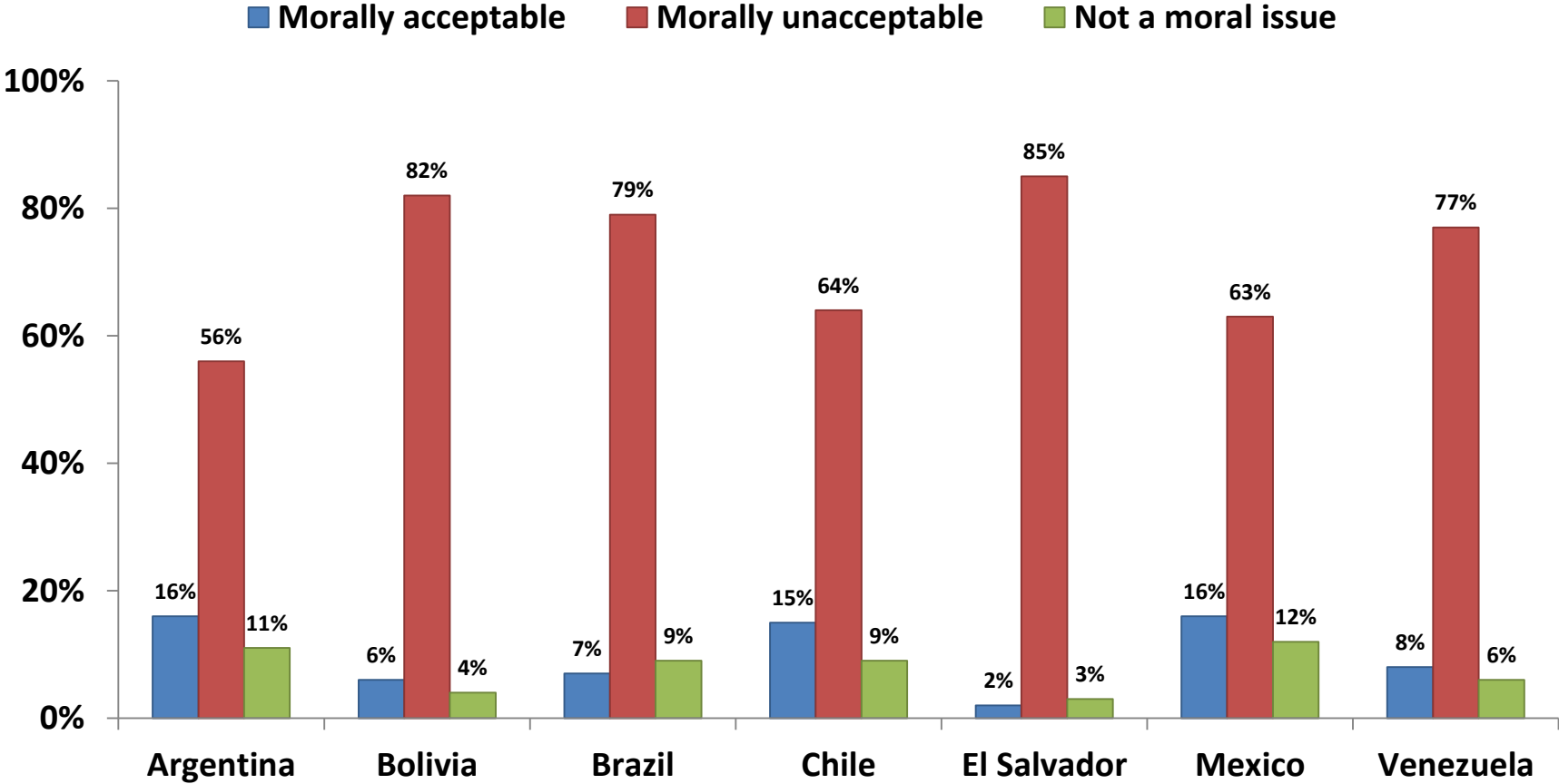


Latin Americans' moral views on homosexuality (2013)



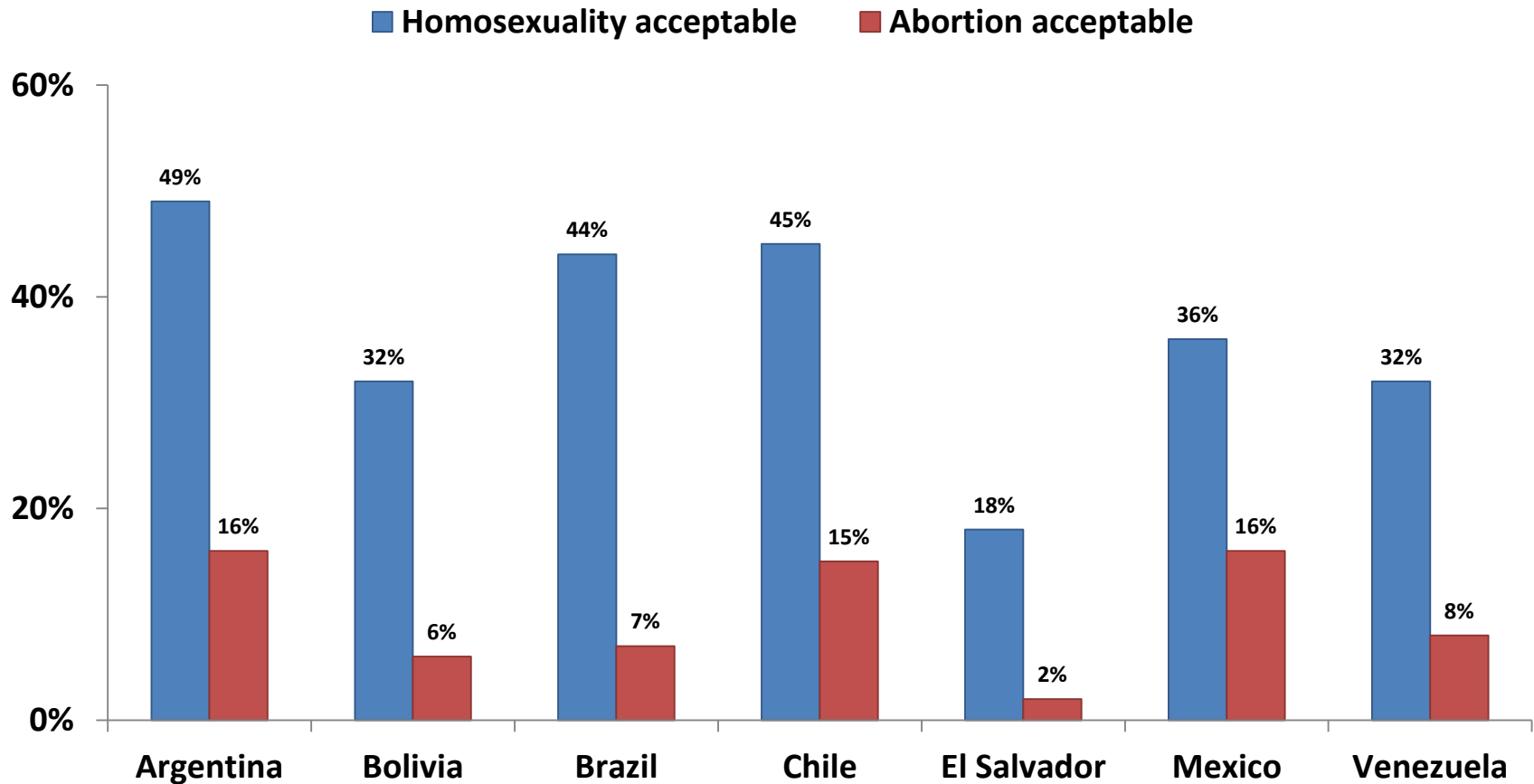

Latin Americans' moral views on abortion (2013)



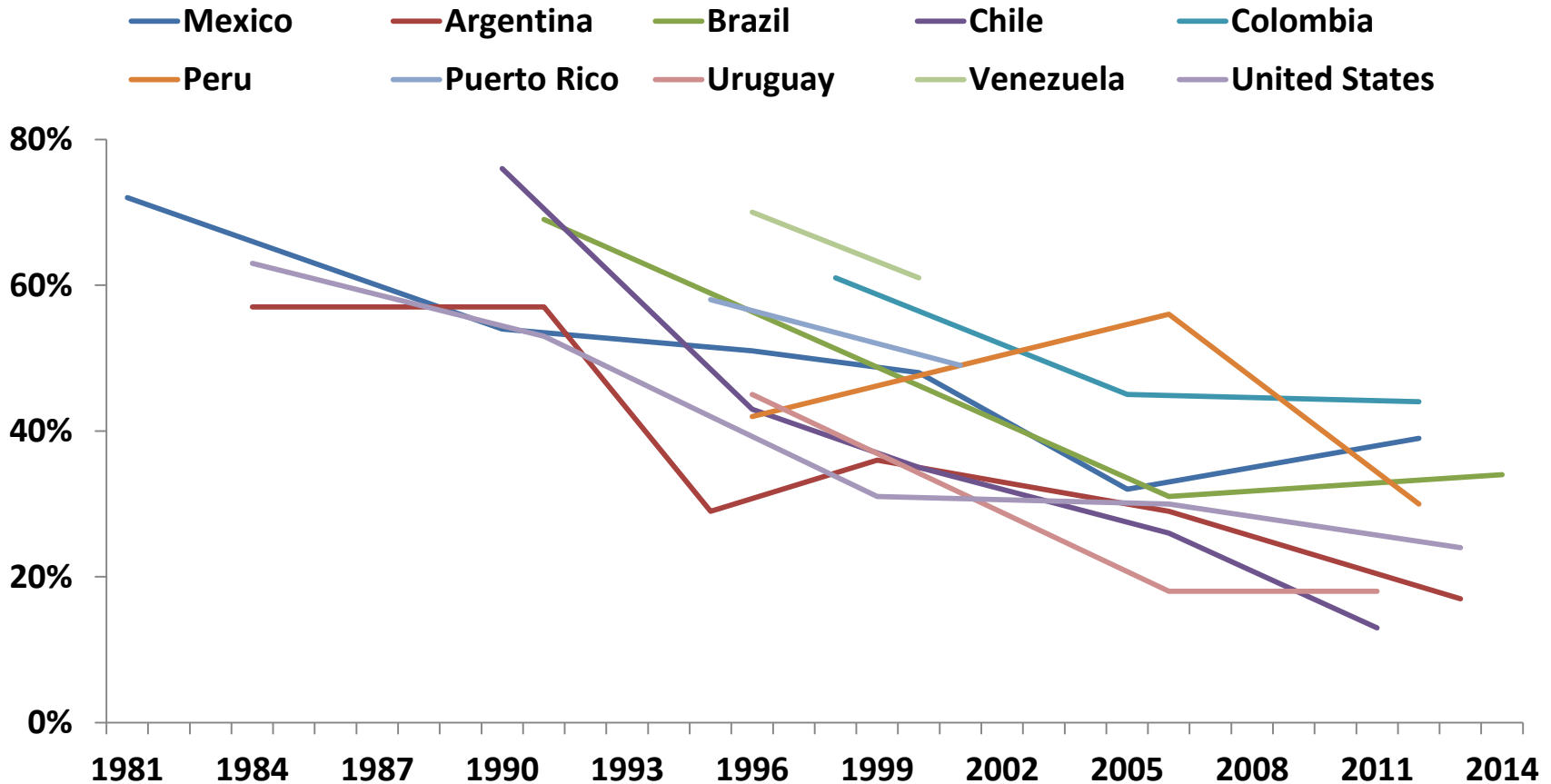

Latin Americans' approval of abortion and homosexuality (2013)



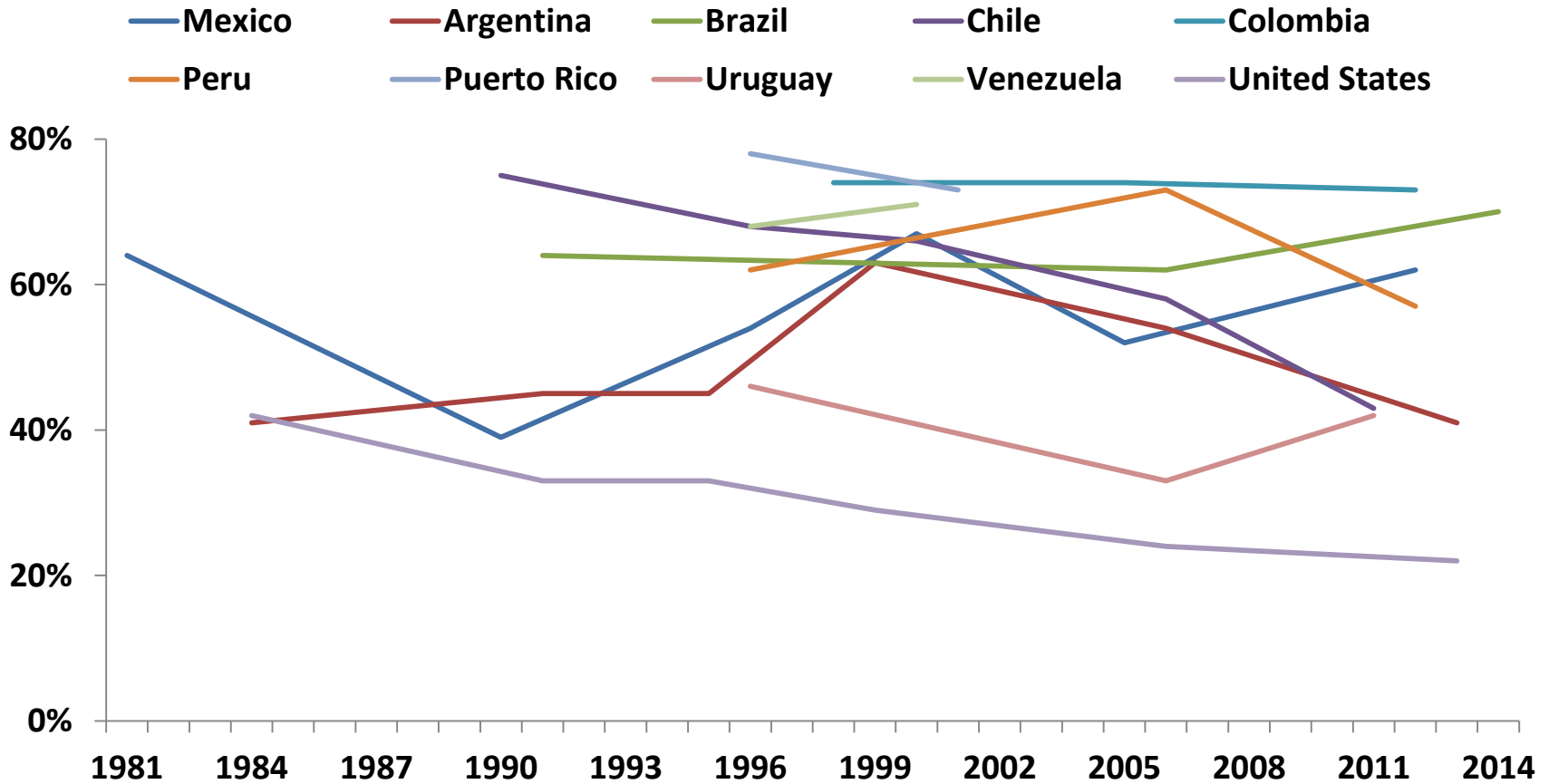

Percent saying homosexuality is 'never justifiable' by country



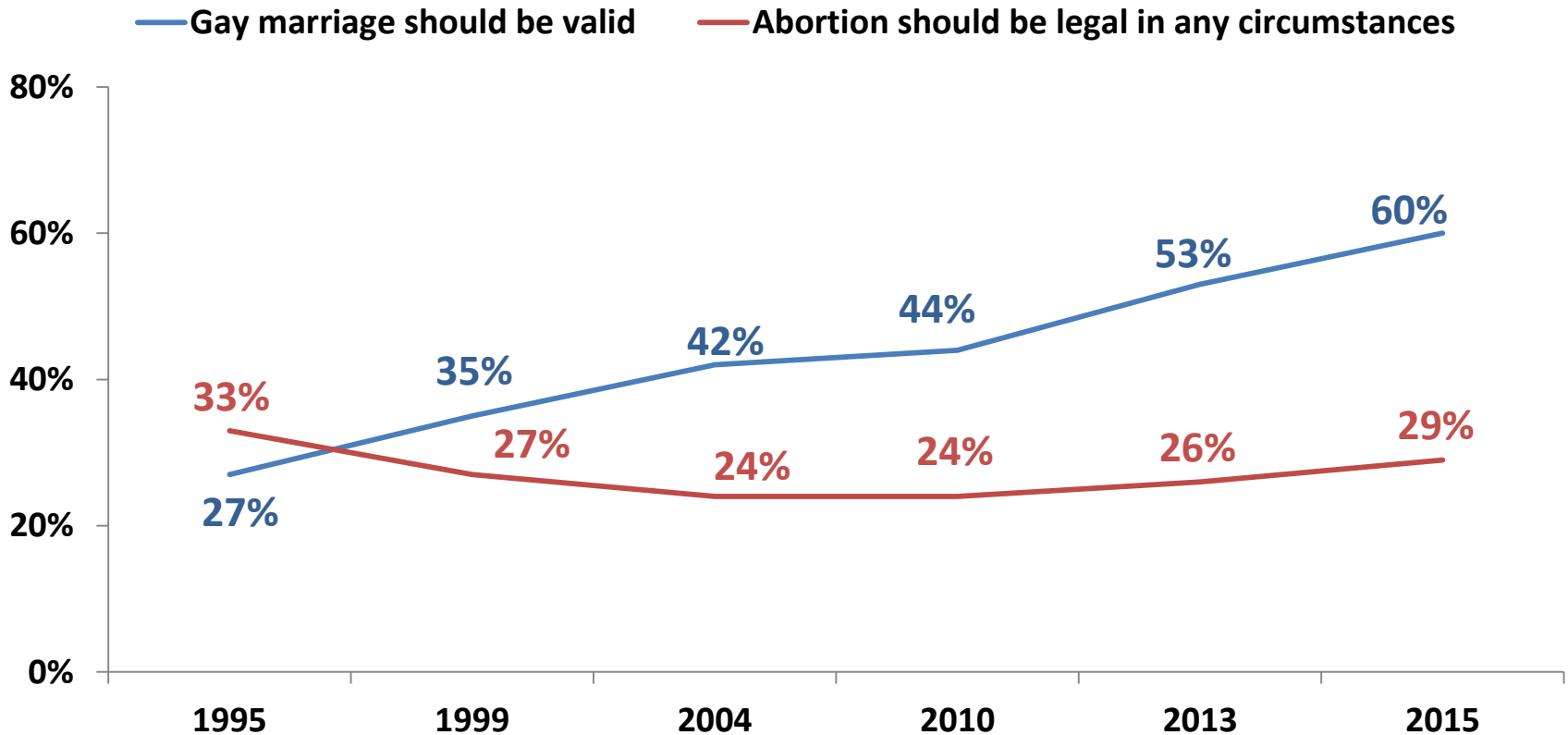

Percent saying abortion is 'never justifiable' by country



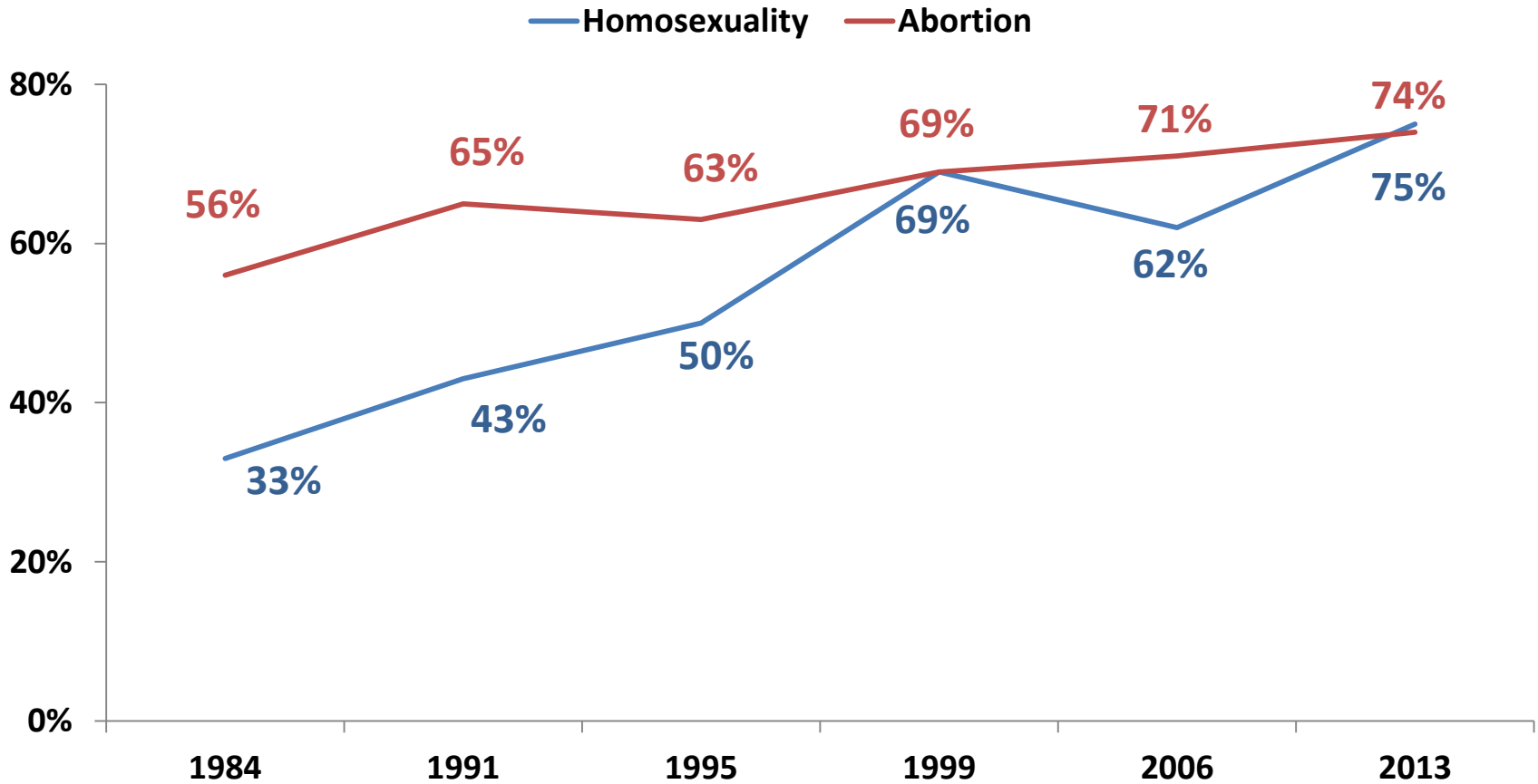

U.S. support for gay marriage and legal abortion



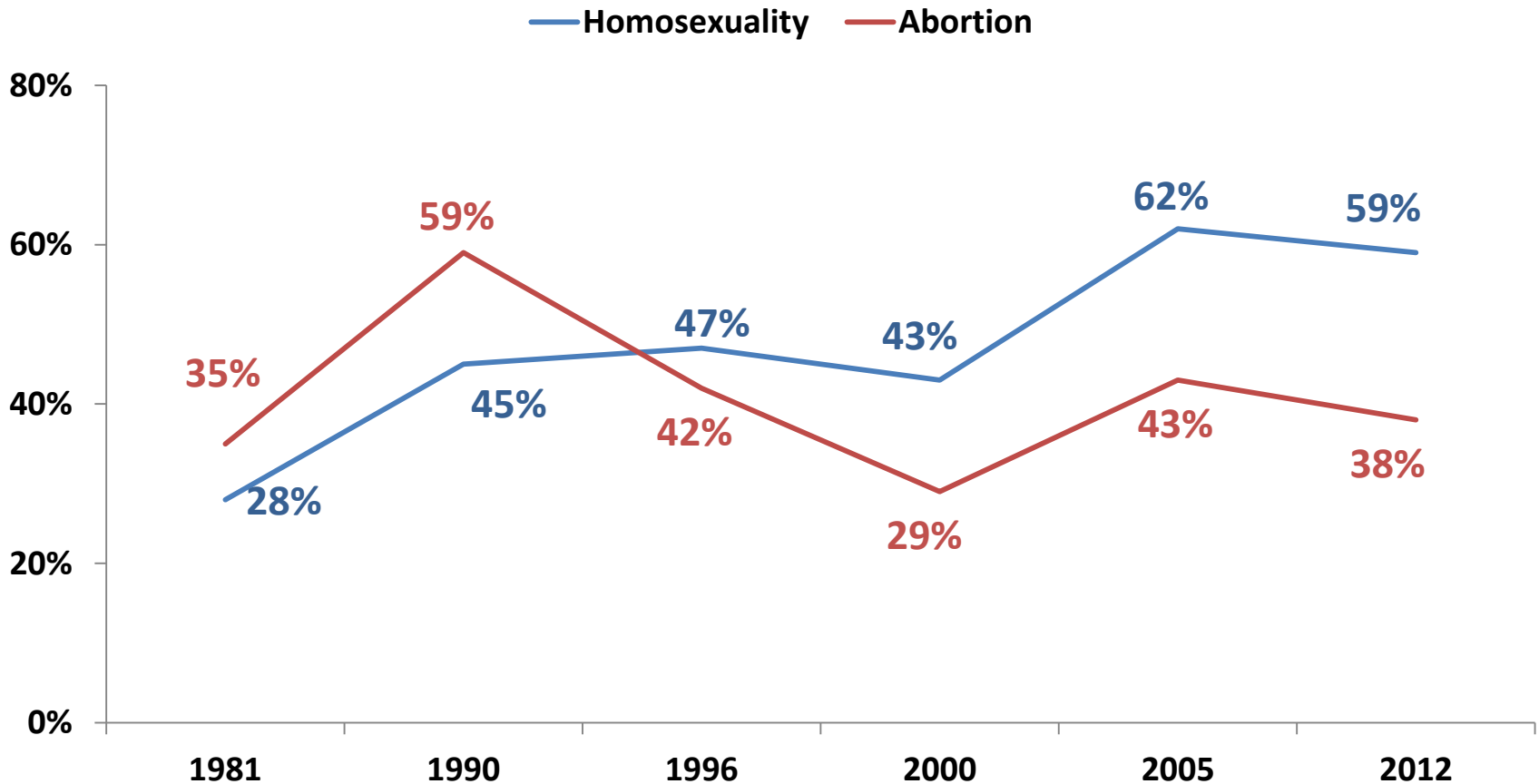
- Do you think abortions should be legal under any circumstances, legal only under certain circumstances, or illegal in all circumstances?

Percent of U.S. saying 'sometimes' or 'always justifiable'



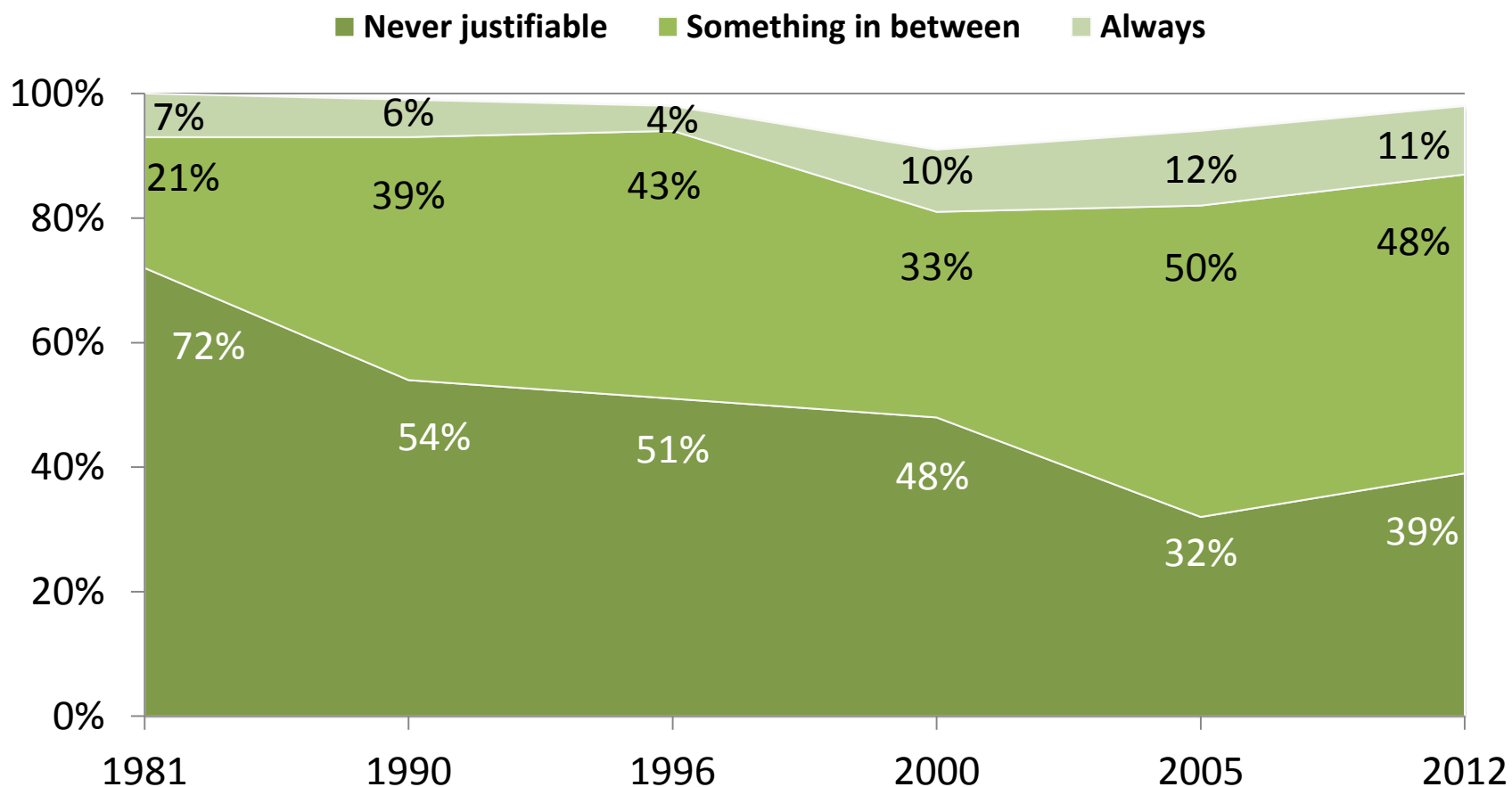

Percent of Mexicans saying 'sometimes' or 'always justifiable'



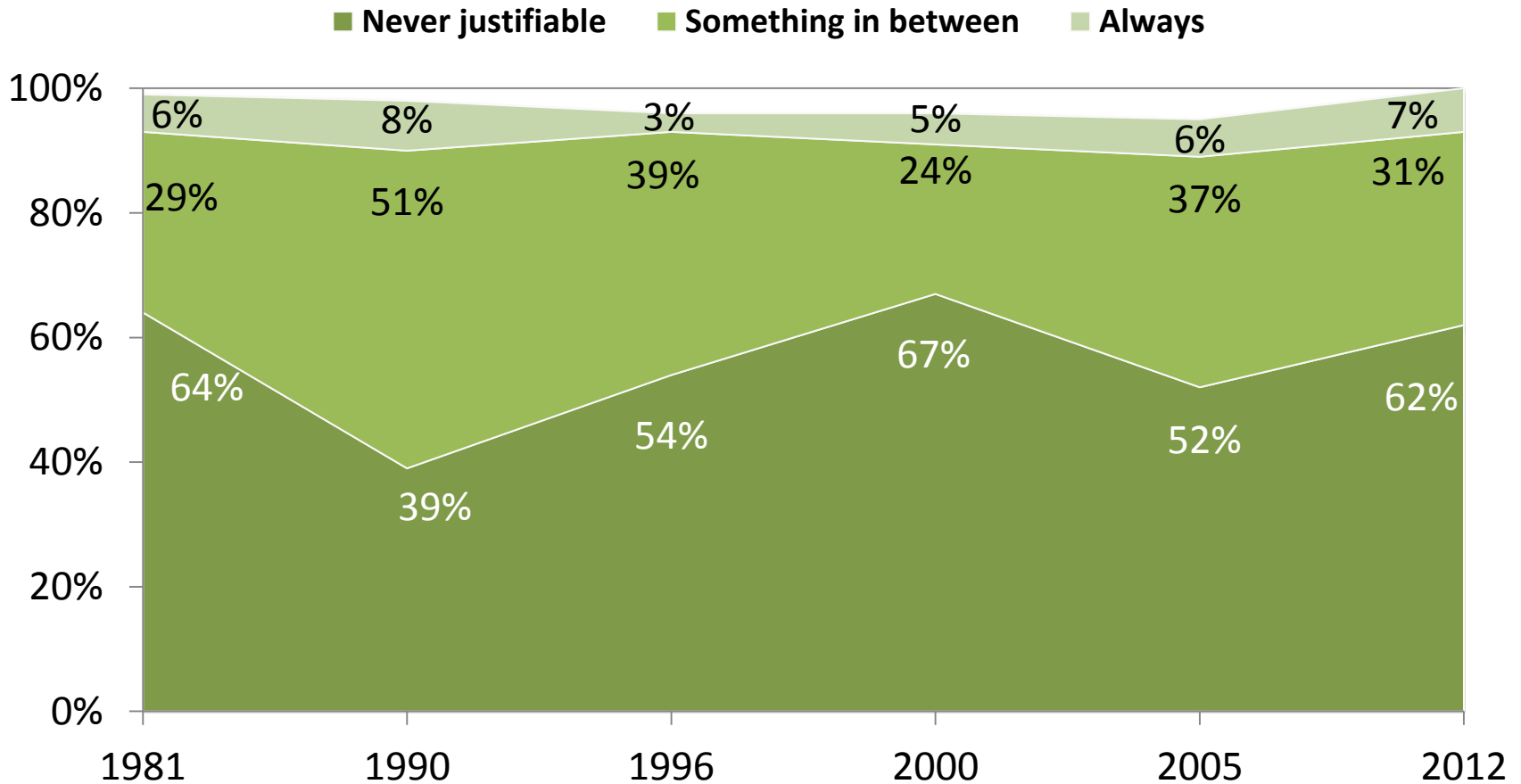
